Your child will be enrolled according to the above schedule. If your child begins care on or before the 15th of the month, a full month's tuition will be due. If your child begins care after the 15th of the month, tuition will be prorated at \$5.00 per morning and \$17.00 per afternoon for the first month of enrollment. A full month's tuition for September through May will be due regardless of holidays, breaks or absence. (Note: June tuition will be prorated based on your child's regular schedule at our daily tuition rate of \$5.00 per morning and \$17.00 per afternoon.)

*** Annual Registration Fee is \$60.00 per family. (Fee is non-refundable.)**

Note: All inclusive tuition includes a reservation on all in service days. All others must pay \$15.00 per day (\$22.00 if AM only) and reserve a spot.

Tuition is due on the first of the month. We extend a grace period until the fifth of the month. On the sixth of the month you will be billed a \$5.00 per day late fee until your full tuition is received. If full tuition payment is not received by the tenth of the month we will suspend your child from the program until the outstanding balance has been brought current.

ASC, Inc. does not make verbal agreements. Any hardship arrangements must be requested in writing and approved in writing by ASC Director, Belinda Gannett.

Tuition reimbursement must be requested two weeks in advance of withdrawing your child from the program or making a permanent schedule change that lasts more than a month AND you must complete and sign a new Fee Agreement. Any such requests should be sent to: belindagannett@yahoo.com

ASC, Inc charges a \$25.00 returned item fee. Unpaid balances will be collected at your expense to the full extent of the law.
